

**CITY OF CAPE CORAL PETITION FORM**

**BALLOT TITLE:** Preserve Jaycee Park as a tranquil, natural green space and neighborhood park.

**BALLOT SUMMARY:** An initiative to preserve jaycee park as a natural green space and neighborhood park, and to prohibit the construction of any sea wall, boat slip, amphitheater, café, and/or bar. No permanent food trucks or other businesses shall be allowed.

**FULL TEXT OF PROPOSED AMENDMENT:** Whereas Jaycee Park is currently a natural green space and neighborhood park in the City of Cape Coral;  
Whereas the City Council has authorized and begun the process of changing the park into a commercial venue;  
Whereas the City Council has ignored the objections of the surrounding residents and people who currently enjoy the park.  
NOW, THEREFORE, residents of Cape Coral demand the City Council cancel the current planned "improvements" to the park and preserve the nature and character of the park as a tranquil green space with a natural shoreline. Specifically, the City Council shall:  
§ 1. Maintain the Character of Jaycee Park  
There shall be no changes or "improvements" to Jaycee Park that alter the character of the park as a natural green space and neighborhood park.  
§ 2. No Permanent Commercial Entities  
Permanent commercial entities in Jaycee Park shall be prohibited. There shall be no bars, cafés, food trucks, or any other commercial establishments permanently erected or allowed to do business in Jaycee Park.  
§ 3. Maintenance of Natural Waterfront  
The natural shoreline of the park shall be preserved. The construction of any type of seawall or concrete barrier along the water is prohibited. There shall be no boat docks or boat slips allowed.  
§ 4. Preservation of Current Trees  
The current trees in the park shall not be removed unless they are dead or diseased.  
§ 5. Prohibition of Amphitheater  
The construction of an amphitheater and any other structure that would destroy the serenity of Jaycee Park shall be prohibited.
